AN ORDINANCE TO ESTABLISH 911 EMERGENCY TELEPHONE SERVICE FOR
THE COUNTY OF Calloway

WHEREAS, the Fiscal Court of the County of Calloway
has determined that the health, safety and welfare of the people of
the County of Calloway will be improved by the
establishment of an Enhanced 911 Emergency Telephone Service (E911);
and

WHEREAS, it is necessary to levy a fee to fund the establishment
and operation of the E911 service; and

WHEREAS, the most economical means of providing E911 service is
to enter into a cooperative agreement with the Kentucky State Police
(KSP) for the establishment and operation of the Public Safety Answering
Point (PSAP) which is an integral part of an E911 service; and

WHEREAS, pursuant to KRS 65.760, the County of Calloway
may by duly enacted local ordinance establish 911 emergency telephone
service, adopt regulations concerning the provision of the service, enter
into cooperative agreements for the operation of the service, and
to levy a fee to fund the establishment and operation of the service;

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Fiscal Court of the
County of Calloway of the Commonwealth of Kentucky as
follows:

1. The County of Calloway, by and through its Judge/
Executive is hereby authorized and empowered to enter into an agreement
with the telephone company to establish and operate an Enhanced 911
Emergency Telephone (E911).
2. Pursuant to KRS 65.760(3), in order to fund the establishment
and operation of the E911 service, an E911 Service Charge is hereby levied
in the sum of \$1.00 per telephone subscriber per month, on an
individual exchange line basis in accordance with the terms of the agree-

3. The telephone company is hereby authorized to collect the E911 Service Charge from the telephone subscribers and shall be entitled to a fee for billing and collecting the E911 Service Charge in an amount not to exceed three percent of the total amount collected.

4. The County of Calloway, by and through its Judge/Executive, is hereby authorized and empowered to enter into an Interlocal Cooperation Agreement with the Kentucky State Police (KSP) for the establishment and operation of a Public Safety Answering Point (PSAP) at the Kentucky State Police Post at Mayfield.

5. The Provisions of this ordinance as severable, and if any provision is found to be unconstitutional or otherwise invalid, the remaining provisions shall continue in full force and effect.

6. This ordinance, upon passage and publication, shall become effective only in the event that the Kentucky State Police institute an E911 service which cost for Calloway County residents does not exceed the amount listed in item two (2) above.
