

**AN ORDINANCE RELATING TO FEES
FOR PURPOSES OF PAYING EXPENSES FOR COURTHOUSES,
BONDS RELATED TO THEM, AND ADMINISTRATION THEREOF**

ORDINANCE NO. 00-0815-B

Be it ordained by the Fiscal Court of the County of Calloway, Commonwealth of Kentucky:

WHEREAS, the 2000 Kentucky General Assembly has provided in the Judicial Branch Budget Bill (HB 577) for fiscal courts to assess by ordinance, additional fees and costs in Circuit and District Courts in civil and criminal cases; and

WHEREAS, HB 577 provides that the Fiscal Court may pass said ordinance for the county to use this money for the purpose of paying expenses for courthouses, bonds related to them, and administration thereof in Circuit and District Court; and

WHEREAS, the Fiscal Court of Calloway County finds that it is in the public interest to pass this ordinance for the aforesaid purposes as provided by HB 577;

NOW, THEREFORE, be it ordained by the Fiscal Court of County of Calloway, Commonwealth of Kentucky, as follows:

SECTION I. The Calloway County Fiscal Court hereby assesses the following additional fees and costs in the Calloway Circuit Court and the Calloway District Court, to wit:

- A. In Circuit Court civil cases, a fee of \$25 shall be added to the filing fees.
- B. In Circuit Court criminal cases, a fee of \$25 shall be added to the court costs that the defendant is required to pay.
- C. In civil cases that are appealed from Circuit Court to the Court of Appeals, a fee of \$25 shall be added to the filing fees.
- D. In all traffic offenses, a fee of \$10 shall be added to the court costs for each traffic offense.
- E. In probate cases, a filing fee of \$10 shall be added to each filing fee.
- F. In misdemeanor cases, a cost of \$20 shall be added to the court costs.
- G. In small claims, a fee of \$10 shall be added to all filing fees.
- H. In District Court civil cases, a fee of \$10 shall be added to all filing fees.

SECTION II. All fees and costs provided in Section I of this Ordinance shall be collected by the Calloway Circuit/District Court Clerk. In accordance with the procedures of the Administrative Office of the Courts, the fees shall be paid to the Calloway County Fiscal Court on a monthly basis.

SECTION III. The Calloway County Fiscal Court hereby assesses the following additional fees and costs on subpoenas and civil summons service by the Calloway County Sheriff's Department, to wit:

A. In addition to the fees normally charged for the service of a subpoena, the person requesting service shall be charged a fee of ten dollars (\$10).

B. In addition to the fees normally charged for the service of a civil summons, the person requesting service shall be charged a fee of ten dollars (\$10).

C. The fees provided by Section III of this Ordinance shall be collected by the Calloway County Sheriff's Department and said fees shall be paid to the Calloway County Fiscal Court on a monthly basis.

SECTION IV. All revenue from the fees and costs collected under this Ordinance shall be used as provided by HB 577 for the purpose of paying expenses for courthouses, bonds related to them, and administration thereof.

SECTION VI. EFFECTIVE DATE: This Ordinance shall become effective on September 1, 2000.
