

AN ORDINANCE ADOPTING
MAGISTRATE DISTRICT BOUNDARIES

ORDINANCE NO. ~~23-0816-A~~

Be it ordained by the Fiscal Court of the County of Calloway, Commonwealth of Kentucky:

WHEREAS, KRS 67.045, requires the Fiscal Court to initiate reapportionment proceedings in May of the first year following the decennial census of the United States; and

WHEREAS, the Calloway Fiscal Court has heretofore appointed three (3) competent citizens of this County over twenty-one (21) years of age, and residing in different districts, and the Calloway County Clerk as a nonvoting member, as commissioners to reapportion magistrate (or justice of the peace) district boundaries in Calloway County; and

WHEREAS, the commissioners have filed their report as provided by law, and have recommended that the Fiscal Court move 8 census blocks from Census Tract 105 Block Group 2 from District 3 to District 2, and move 13 census blocks from Census Tract 106.01 Block Group 2 from District 3 to District 2; and

WHEREAS, moving the recommended boundary in essence moves 791 people from District 3 to District 2 bringing the deviation between all district populations to less than 1%;

WHEREAS, the Fiscal Court of Calloway County finds that it is in the public interest to accept said recommendations;


NOW, THEREFORE, be it ordained by the Fiscal Court of County of Calloway, Commonwealth of Kentucky, as follows:

SECTION 1. The Calloway County Fiscal Court hereby adopts and accepts the Report of the Commissioners, appointed pursuant to KRS 67.045, and establishes the new boundary between District 2 and 3, and continues the same district boundaries between the other districts that were heretofore established under the preceding redistricting.


SECTION 2. The metes and bounds description and the map of the magistrate districts are incorporated herein and made a part of this ordinance by reference.

SECTION 3. EFFECTIVE DATE: This Ordinance shall become effective upon its publication and second reading as provided by KRS 67.077.


The First Reading of this Ordinance occurred on the 21st day of June, 2023. This Ordinance was published not more than seven (7) days nor more than twenty-one (21) days prior to passage on the 12th day of July, 2023. The Second Reading of this Ordinance and passage occurred on the 19th day of July, 2023.





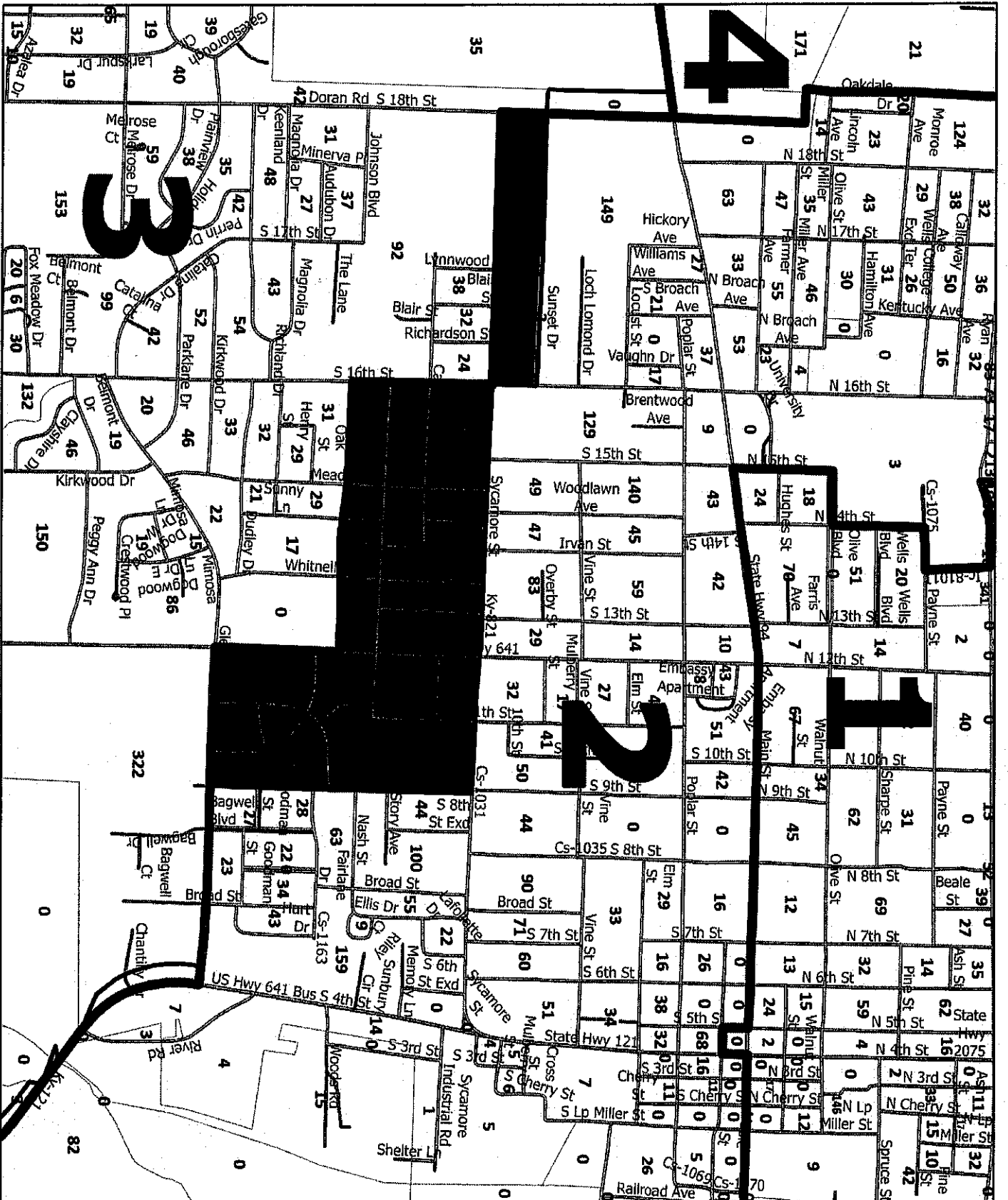

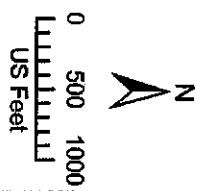
