CALLOWAY COUNTY FISCAL COURT MEETING July 26, 2024, Special Meeting

An adjourned special called meeting of the Calloway County Fiscal Court was held at 12:00 pm on Friday, July 26, 2024, in the Calloway County Court House Annex. Judge Executive Kenneth C. Imes called the meeting to order. The following duly qualified members of the Court were present: Squire Don Cherry, Squire Paul Rister, Squire Larry Crutcher and Squire Ricky Stewart. Also present were Deputy Judge Executive Gina Winchester, Co Attorney K. Bryan Ernstberger, and County Clerk Antonia Faulkner.

The Court discussed the approval of land acquisition for Old Salem Bridge right-of-way construction. Additional land was needed to allow the right curvature of road approaching the proposed new bridge location. Motion made by Squire Crutcher seconded by Squire Stewart to authorize Judge Imes to sign documents necessary for the transfer and for the Treasurer to issue the check for payment of \$10,000.00 for .424 acers right-of-way from Sundown Property Holdings, LLC. All voted aye and it was so ordered.

The Court heard from EMS Director Josh Kerr regarding the declaration by FEMA issued on July 23, 2024, for the storms that occurred during the period of May 21st-27th, 2024, in Calloway County. Information on public and individual assistance will be forth coming.

The Court discussed the agreement for KYTC Rural and Municipal Aid for Calloway County. Motion made by Squire Rister seconded by Squire Crutcher to approve the agreement and resolution #24-0726-A as presented. Squire Rister questioned that Harry Truman was not on the included list of roads to be paved along with neighboring roads Abe Lincoln and John Purdom. Jüdge Imes agreed that Harry Truman should have been on the list and would follow up. With the assurance that Harry Truman would be paved along with the other two aforementioned roads, all voted aye, and it was so ordered.

Judge Imes asked the Court to authorize him to sign an Interlocal Agreement: West Kentucky Law Enforcement Mental Health and Resiliency Program. The program provides for peer support teams. The program would help members of law enforcement with needs related to peer support due to its vocation involving traumatic experiences. It will include Marshall and Calloway County Sheriff, and Benton, Calvert City and Murray City Police, and Murray State University Campus Police. Funds would go to Marshall County Sheriff's department to be used for all agencies. Motion made by Squire Rister seconded by Squire Stewart to approve the agreement as presented. All voted aye and it was so ordered.

There being no further business before the Court motion made by Squire Rister seconded by Squire Crutcher to adjourn. All voted age and it was so ordered.
