**S 1-c A. C. KING, 19**, son of Mrs. Susie King, Murray, was drafted into the Navy from this county Jan. 27, 1944. He received training at Great Lakes, Ill., and Bainbridge, Md., before going on sea duty September, 1944. King was in many battles in the Pacific including Iwo Jima, Okinawa, Marianas and Philippines. He was wounded when his ship, Indianapolis, was sunk off Leyte, and was one of the few survivors of the sinking. King is in a hospital on Guam and has the Good Conduct ribbon, China Sea ribbon, Pacific Theater ribbon, and eight battle stars. A graduate of Murray Training School, he was in defense work before induction, and has one brother, William King, in service.



**PFC. WILLIAM M. KING, JR.**, son of Mrs. Era King, formerly of Hazel, volunteered from here in 1941. With the Fourth Division which originated in World War I, he served in the European Theater, first landing on Normandy on June 6, helped to capture Paris, then went to Luxembourg and Metz. Pfc. King also served in Belgium and Germany. He wears the Purple Heart with one bronze oak leaf cluster for wounds received in action in Germany on April 9, 1945, and the Bronze Star medal.

**CPL. T. J. KIRKS** was drafted from this county Oct. 27, 1942, and served with the 359th Quarter Master Truck Company, going overseas Feb. 21, 1944, and serving in the European Theater. He was awarded the American Theater ribbon, the EAME ribbon with five stars, the Good Conduct ribbon and the Victory medal. He is married to Miss Sue McReynolds and they have a daughter, Janice Fay.



**S 2-c WILLIAM KING, Jr., 18**, son of Mrs. Susie King, Murray, was drafted into the Navy Feb. 1, 1945, from this county. After training at Camp Peary, Va., he was given sea duty June, 1945, and is in the South Pacific. King attended Hazel high school and was a N.Y.A. student in Detroit before induction. He is married to the former Miss Geraldine Smith, and has a brother, S 1-c A. C. King, in the Navy.



**O-C EDWARD FRANK KIRK, 30**, son of Mrs. Katherine Kirk, was drafted in April, 1945. With the Infantry, he trained at Camp Rucker, Ala., before going to Officer Candidate School at Ft. Benning, Ga. His wife is the former Miss Reba Hale, and they have a daughter, Mary Edwina.



**LT. ALVIN HANLEY KOPPERUD**, son of Dr. and Mrs. Alvin

Kopperud, was drafted Sept. 21, 1943. He trained at Camp Grant, Ill., Ann Arbor, Mich., and Camp Beale, Calif. Leaving the States in 1944, he was sent to Richardson, Alaska where he acted as Post Judge Advocate, Post Legal Officer, and Post Claims Officer. Lt. Kopperud is married to the former Miss Hallie Rudolph, and they have a son, Billy.



**SC 1-C RAY WESLEY KUYKENDALL**, husband of Mrs. Ila Lamb Kuykendall, Route 2, Murray, and son of Joe Kuykendall, Cincinnati, Ohio, was drafted into the Navy Oct. 13, 1942. He went to Davesville, R. I., for training and went overseas March, 1943. Kuykendall was given a discharge Aug. 15, 1945, and resides on Route 2, Murray.

**JOE M. KNIGHT** was drafted in November, 1943.
