HAFFORD G. SILLS was drafted from this county October 27, 1942

SGT. WILLIAM L. SIMS was drafted February 23, 1942, and served with the 213th AAF Base Unit in India and Burma after going overseas October 7, 1942. Before receiving a discharge October 26, 1945, he was awarded the American Theater ribbon, the EAME ribbon, the Asiatic-Pacific ribbon with one star, and the Good Conduct medal.

PVT. JOE M. SIRLS was wounded in France November 20, 1944. He is the son of Mrs. Hilda S. Sirls, Dexter.

JOE R. SIMS was drafted March17, 1943.

LT. COL. W. M. SLAYDEN was drafted from the county December 12, 1940. He served with the 11th Armored Division in Austria. He was a TVA attorney in Murray before entering service.



WILLIAM REXIE TABERS was drafted February, 1944, and was Hospital Apprentice, second class. He is the son of Mr. and Mrs. William Oscar Tabers. He took his training in Great Lakes.

JAMES LEWIS TABORS entered service February 1944.

JOSHUA H. TABERS was drafted January 2, 1943.



PFC. JOE EUGENE TARRY, Jr., son of Mr. and Mrs. Eugene Tarry, was drafted into the Army March 28, 1944. He received his training at Camp Blanding, Fla., and went overseas September 1944. Pfc Tarry received the Combat Infantryman's badge, Good Conduct ribbon, Presidential Unit Citation, and EAME ribbon with two campaign stars. He is married to the former Miss Roberta Pucket and they have two sons, Joe and Charles.



CPL. CODIE A. TAYLOR, 27 year old son of Mr. and Mrs. Floyd Taylor. Route 4, Murray, was drafted from this county Feb. 28, 1944. He went overseas Aug. 17, 1944, and in December, 1944, was captured by the Germans in the Battle of the Bulge. Being wounded he spent many weeks in a German hospital and was taken to a German prison camp, until liberated by the British. Cpl. Taylor won the Purple Heart Combat Infantry Badge, and the ETO ribbon.



PFC. TOMMYE D. TAYLOR, 18. son of Mr. and Mrs. John Tom Taylor, was drafted in 1945. As-signed to the Army Air Corps, he received his basic training at Shep-pard Field, Texas. Private Taylor was stationed at Keesler Field,



CPL. HENRY CARLTON TAY-LOE, 24, son of Mr., and Mrs. L.

M. Taylor, Route 4, Murray, was drafted from this county Sept. 30, 1942. Receiving his training as a mechanic in the Army Air Corps, he was stationed at Roswell, N. M., and Denver, Col. In January, 1944, Cpl. Taylor was sent to India, and has been awarded the CBI ribbon with two battle stars and a Presidential Citation.

JOHN F. TAYLOR entered service March 8, 1941.



COMMANDER H. BOYCE TAYLOR, son of the late Rev. H. Boyce Taylor and Mrs. Taylor, served in World War I, and remained in the Reserve until 1941, when he was called into active service. He served as commander of a flotilla of ships in the Pacific area. He was returned to the States in 1945. He and his family reside in Jackson-ville, Fla. He was awarded the Pre-Pearl Harbor and Navy Reserve ribbons, a Pacific Area ribbon with three battle stars, and a Philippine Zone ribbon with one star.



PVT. STARKIE KEYS THOMAS, 33, son of the late Mr. and Mrs. T. A. Thomas, and brother of Prentice Thomas, was drafted March 1, 1945. As an Army engineer, he received training at Camp Blanding, Fla., Fort Belvoir, Va., and Camp Beale, Calif.

PVT. JAMES F. THOMPSON, 19, son of Mrs. Gela Thompson, Route 2, Murray, volunteered for the Marines Jan. 14, 1944. As a radio and radar technician, he trained at the N.A.T.T.C. School, Memphis, Tenn., before going overseas in January. 1945. Pfc. Thompson was stationed at the air base on Guam.



SGT. JOHN DAVID THOMP-SON, 25, son of Mrs. Gela Thompson, Route 2, Murray, was drafted Dec. 4, 1942. In the Army Engineers, he trained at Camp Van Doin, Miss., and Camp Maxey, Tex., going overseas September, 1944. Sgt. Thompson, who was in the 99th Division with the 1st and 3rd armies, is in Frankfurt, Germany, and has the Bronze Star and the ETO ribbon with three battle stars. A graduate of Murray Training School, he attended M.S.T.C., and had a brother, Pvt. James F. Thompson, in the Marines.

SGT. MARSHALL D. THOMP-SON was drafted October 18, 1943, and received his basic training at Fort Sill., Okla. He was sent to Fert Meade, Md. He wan overseas May 1, 1944, serving with the 95th, 34th and 88th Infantry Divisions in Italy. He was awarded the EAME ribbon with three battle stars, the Victory ribbon and the Good Conduct ribbon. He was discharged January 27, 1948.



PFC. GALEN M. THURMAN, Jr., 18, son of Mr. and Mrs. Galen Thurman, volunteered for the Marines January 13, 1944. After being stationed at San Diego, Calif., as a picture projector until March, 1945, he was sent to Japan.



SGT. JAMES PRESTON THUR-MAN, son of Mrs. Lois Thurman, Route 3. Murray, volunteered for service February 26. 1941, going overseas November, 1942. With the Infantry, he was wounded in Italy February, 1944, and returned to the States in August after 21 months overseas. Sgt. Thurman fought at Casablanca, through North Africa, Sicily and Italy, and was awarded the Purple Heart, American Defense Medal, Good Conduct ribbon, Combat Infantry Badge, American Theater ribbon and European ribbon. He had two brothers, S-Sgt. William Herbert and Pyt. Howell B. Thurman, in service.





CPL. JOHN STEWART THURMAN, 22, son of Mr. and Mrs. Walter N. Thurman, was drafted from this county. November 10, 1942. He took his training at Ft. Benjamin Harrison, Ind., and Miami Beach, Fla. and went overseas December, 1944. He is a graduate of Concord high school and, prior to his induction, was a farmer. Cpl.
